Elijah's Promise addresses the problem of hunger in New Brunswick, New Jersey by providing more than 100,000 meals annually through different feeding programs. In addition to being a healthy soup kitchen and food pantry, they offer a culinary program. The Northfield Bank Foundation grant was given for the culinary training program which teaches hundreds of low-income students culinary skills to prepare them for the work force.


